**14-173 Motion presented by Councillor Giannino: That the Mayor request the Department of Public Works to repair the catch basin at the corner of Shawmut Street and Wonderland. The damaged catch basin causes standing water and unsanitary conditions that are a breeding ground for mosquitoes.**
