2. Roll Call: Councillors Arrigo, Guinasso, Haas, Patch, Penta, Powers, Reardon, Zambuto and President Novoselsky present. Councillor Correggio seated at 10:05 A.M. Councillor Giannino absent.

13-285 3. Communication from Mohegan Sun Massachusetts:

**Re: Request for a Host Community Election Pursuant to MGL c. 23K § 15 (13) and 205 CMR 124.02**

Mohegan Sun Massachusetts, LLC (Mohegan Sun) executed a host community agreement with the City of Revere on December 23, 2013 in accordance with MGL c. 23K and 205 CMR 123.02.

In accordance with the Expanded Gaming Act, please accept this letter as Mohegan Sun's formal request for a host community election pursuant to MGL c. 23K § 15 (13) and 205 CMR 124.02 (1). Mohegan Sun requests that such host community election be held on February 25, 2014, which is 60 to 90 days from your receipt of this request as required by MGL c. 23K § 15 (13).

Mayor Rizzo addressed the Council at this time

Motion presented by Councillor Zambuto: That the Revere City Council hereby offers a vote of confidence to Mayor Rizzo regarding the "Host Community Agreement" by and between the City of Revere and Mohegan Sun Massachusetts, LLC.

In City Council December 27, 2013, unanimously ordered on a voice vote.

13-286 Motion presented by the Revere City Council: That the Revere City Council hereby authorized the scheduling and holding of a host community election on February 25, 2014, in accordance with MGL c. 23K § 15 (13) and 205 CMR 124.02 (1) on a ballot question relative to the operation of a gaming establishment in Revere pursuant to a Category I gaming license issued by the Massachusetts Gaming Commission having received a request for such an election from Mohegan Sun Massachusetts, LLC.

**Motion was declared Ordered on a Roll Call: Councillors Arrigo, Correggio, Guinasso, Haas, Patch, Penta, Powers, Reardon, Zambuto and Council President Novoselsky voting “YES”. Councillor Giannino was absent.**

**Councillor Penta moved suspension of rules at this time for the purpose of filing reconsideration on the vote taken.**

**Councillor Penta moved – immediate reconsideration hoping it would not prevail.**

**Reconsideration was declared Lost.**

**Councillor Penta referred back to the regular order of business.**

**Councillor Zambuto moved – that the Revere City Council now stands adjourned to meet on Monday, January 06, 2014.**
