- 7. To amend Title 10, Chapter 10.32, Section 10.32.160 of the Revised Ordinances of the City of Revere Buses and Taxis Away From Stops or Stands by adding the following sub-sections to the end of the section.
  - A. The owner or lessee of any bus, taxicab, hackney, pupil or livery shall be allowed to park in metered parking spaces, provided such owner or lessee pays the parking meter and does not violate the time limit restrictions of the metered parking space.
  - **B.** The owner or lessee of any bus, taxicab, hackney, pupil or livery shall be allowed to park in parking spaces designated as "15 minute parking" or "30 minute parking", provided such owner or lessee does not violate the time limit restrictions of parking spaces designated as such.
