INVITATION TO BID

Separate sealed bids for construction of Beachmont - Sales Creek Neighborhood Sewer and Drainage Improvements Project, CWSRF 4051 WW-002 in the City of Revere, City Bid No. DPCD-2018-1009 will be received by the City of Revere Purchasing Department Agent, Marie Zelandi, at her office, Revere City Hall, 281 Broadway, Revere, MA, prior to 10:00 am, November 8, 2018, and at that time and place bids will be publicly opened and read aloud. Time stamp in the Purchasing Office shall govern the time.

A pre-bid conference will be held on October 25, 2018 at 9:00AM at the CDM Smith field office, 184 Shirley Ave, Revere, MA 02151.

The work of this Contract includes, but is not necessarily limited to furnishing and installing a new wastewater pump station on George Avenue; removing and replacing approximately 2,700ø of sewer on Henry Street, Dolphin Avenue, George Avenue and Jones Road (the Beachmont-Sales Creek Neighborhood); rehabilitating the sewer on Atlantic Avenue; performing rehabilitation on the drain in the Beachmont-Sales Creek Neighborhood within the roadway and through cross country locations including approximately 1,500ø of removing and replacing existing drain and furnishing and installing new drain, and approximately 1,200ø of cleaning and lining existing drain; redirecting private inflow sources; removing and properly disposing of all trench material, and providing new clean backfill material; roadway restoration and all else incidental to the Project.

The Contract Time shall be a total of 563 calendar days, excluding winter shut down and final paving, commencing ten (10) days following the effective date of the Agreement.

Contract Documents may be examined and/or obtained at Revere City Hall, Office of the Purchasing Agent, 281 Broadway, Revere, MA, 02151. Revere City Hall hours are 8:15 AM to 5:00 PM, Monday through Thursday and 8:15 AM through 12:15PM on Fridays. Contract Documents will be available on October 11, 2018 at 10:00 A.M. Contract Documents are available for examination online at http://dodgeprojects.construction.com/

A deposit of \$50 in money order, bank or certified check payable to the City of Revere, Massachusetts will be required for each set of the Contract Documents. A refund of the deposit will be made for such Documents returned in good condition within 30 days after the Bids are received.

Bidders requesting Contract Documents by mail shall include a separate money order, bank certified or certified check in the amount of \$25 per set, made payable to the City of Revere to cover costs of handling and mailing.

Bids shall be submitted in accordance with the Instructions to Bidders and be accompanied by a Bid Security, satisfactory to the City, in the amount of five percent of the Bid. Surety is to be in the form of a certified, cashiers or treasurers check, drawn on a responsible bank or trust company; or bid bond issued by a company licensed to do business in the Commonwealth.

Bids are to be sealed in an envelope, marked on the outside with the words õBeachmont ó Sales Creek Neighborhood Sewer and Drainage Improvements Project, CWSRF 4051 WW-002 City Bid No. DPCD ó 2018 ó 1009ö and returned to the Purchasing Department prior to the opening date and time.

Bidders may not withdraw their Bids for a period of thirty days, excluding Saturdays, Sundays, and legal holidays after the actual date of the opening of the Bids.

The Successful Bidder must furnish a 100 percent Performance Bond and a 100 percent Payment Bond with a surety company acceptable to the Owner.

Complete instructions for filing Bids are included in the Instructions to Bidders.

Minimum Wage Rates as determined by the Commissioner of Department of Workforce Development under the provisions of the Massachusetts General Laws, Chapter 149, Section 26 to 27H, as amended, apply to this project. It is the responsibility of the Contractor, before bid opening, to request if necessary, any additional information on Minimum Wage Rates for those tradespeople who may be employed for the proposed work under this Contract. Federal Minimum Wage Rates as determined by the United States Department of Labor under the Davis-Bacon Act also apply to this Project.

The bidding and award of this Contract will be under the provisions of M.G.L. Chapter 30, Section 39M.

The Owner reserves the right to waive any informality in or to reject any or all Bids if deemed to be in its best interest.

The work under this Contract is funded by the City of Revere through the Massachusetts Clean Water Trust (the "Trust").

Disadvantaged Business Enterprise (DBE) goals are applicable to the total dollars paid to the construction contract. The goals for this project are a minimum of **4.20 percent D/MBE participation and 4.50 percent D/WBE participation** by certified DBEs. The two low bidders shall submit completed DBE forms (EEO-DEP-190C & EEO-DEP-191C and the DBE Certification of United States Citizenship Form) by the close of business on the third business day after the bid opening. Failure to comply with the requirements of this paragraph may be deemed to render a proposal non-responsive. No waiver of any provision of this section will be granted unless approved by the Department of Environmental Protection (MassDEP).

This Project requires compliance with the Department of Environmental Protectionøs (DEP) Diesel Retrofit Program by use of after-engine emission controls that are EPA certified, or their equivalent, on all of the off-road (non-registered) diesel vehicles/equipment, and vehicles greater than 50 brake horsepower, which will be used in the performance of this work.
